ADDENDUM 1: CLARIFICATION & EXTENSION OF CLOSING DATE

TENDER FOR SUPPLY AND DELIVERY OF AUTOMOTIVE GAS OIL (AGO) FOR MENENGAI AND BARINGO GEOTHERMAL PROJECTS THROUGH FRAMEWORK AGREEMENT FOR A PERIOD OF TWO (2) YEARS – REF NO. GDC/SC/OT/024/20-21

In response to bidder's request for clarification, GDC wishes to provide the following clarification;

Bidder's Question 1

Price Schedule form is not provided in the tender documents. Please clarify if this will be provided to interested bidders.

GDC Response

Price Schedule is not included in the tender document since bidders that will meet the requisite pass mark threshold as stated in the technical evaluation criteria will be shortlisted and invited for a minicompetition where price schedule will be provided for bides to quote.

Bidder's Question 2

Reference is made to Paragraph 2.14.7 which is missing in the tender document. Please confirm if this paragraph is part of the tender.

GDC Response

GDC wishes to include the clause as follows;

- 2.14.4 Any tender not secured in accordance with paragraph 2.14.1 and 2.14.3 will be rejected by the Procuring entity as non-responsive, pursuant to paragraph 2.22
- 2.14.5 Unsuccessful Tenderer's tender security will be discharged or returned as promptly as possible as but not later than thirty (30) days after the expiration of the period of tender validity prescribed by the Procuring entity.
- 2.14.6 The successful Tenderer's tender security will be discharged upon the tenderer signing the contract, pursuant to paragraph 2.27 and furnishing the performance security, pursuant to paragraph 2.28

2.14.7 The tender security may be forfeited:

- (a) if a tenderer withdraws its tender during the period of tender validity specified by the procuring entity on the Tender Form; or
- (b) in the case of a successful tenderer, if the tenderer fails:
 - (i) to sign the contract in accordance with paragraph 2.27 or
 - (ii) to furnish performance security in accordance with paragraph 2.28

GDC wishes to extend the tender closing date from Friday 13th November, 2020 to Wednesday 18th November, 2020 at 2.00Pm. This is meant to give bidders adequate time to prepare and respond to the bid.

NB: All other instruction remain unchanged.
