ADDENDUM 1: REQUEST FOR CLARIFICATION

RE: EXPRESSION OF INTEREST (EOI) FOR RECRUITMENT OF GEOTHERMAL ADVISORY BOARD (GAB) MEMBERS OF GEOTHERMAL DEVELOPMENT COMPANY LTD

In response to bidder's/individual's request for clarification, GDC wishes to respond as follows;

Bidders Question 1

What do you pay for my services, and if travel and accommodation will be covered? How many times per year will I have to travel and how much work will this be per year?

GDC response:

This requirement will be addressed under the Request for Proposal stage where shortlisted individuals will be required to submit their technical and financial proposals.

Individuals are also allowed to courier their response in the manner and address provided in the expression of interest to reach GDC on or before the EOI closing date.

Bidders Question 3

Could you please clarify if the EOI is limited to an individual person, or if you are open to a small consultancy offering a range of personnel?

Bidders Question 4

Will proposals be considered for each of the six (6) experts separately or will proposals that offer to provide all of the experts be given preference?

GDC response:

Proposals will be considered for each of the six experts separately.

Bidders Question 5

In the eligibility/evaluation requirements please clarify on item (ii) which requires the person to provide specific information on work plan and methodology including contingency plan? The EOI does not provide any Terms of Reference for the assignment and therefore it's not clear how a work plan can be developed.

Please refer to the scope of works specified in the expression of interest. The detailed Terms of Reference will be provided under the Request for Proposal for shortlisted individuals

Bidders Question 6

In the same eligibility/evaluation criteria, please on item (vi) which requires evidence of three major clients references. What sort of evidence is required here?

You are required to provide listing and a brief description of the work done including the contacts of the clients.
