Kindly ignore the tender number appearing at the footer. The Correct Tender Number is: GDC/ICT/OT/026/2016-2017.
2.	Kindly Clarify whether all supply Delivery & Installation works are being done at Kawi House to guide in charging for labour & logistics.	This is a general tender requirement. Kindly refer to each Schedule for the specific requirement of the Schedules. Note: Award will be per schedule. Kindly refer to Particulars of Appendix to instructions to tenders; clause 2.27 page 16.
3.	Schedule 1, 2 & 3 – Minimum of two (2) years of warranty assurance. Page 36 under Support, the same requirement is mentioned as 1 year Next Business Day support for hardware as well as 1 year 24x7 support for the controller licenses should be quotes as well. Should Warranty support for the hardware be 1 OR 2 YEARS?	Warranty for the hardware is two (2) years. Support for the controller licenses should be quoted for one year renewable annually

4.	Kindly clarify whether GDC needs SLA support (Onsite/Remote, E-Mail)for all the items from the Bidder in line with the Warranty period of 1 year or 2 Years	Support for the controller licenses should be quoted for one year renewable annually.
5.	2.27 Each complete schedule shall be evaluated and awarded separately. Each of these schedules are interdependent on each other, please advice on how project will be coordinated to achieve the intended solution if various bidders are awarded each schedule.	Each Schedule is independent and therefore award will be per schedule. We treat each project independently.
6.	Category 6e Network cables to be delivered in Nakuru (GDC Polo Center) Page 37 indicates that Deliveries for the UTP CATEGORY 6 CABLE are to be done to GDC Store at Kawi House-Nairobi. Please clarify is the delivery to be done in Nakuru or Kawi House?	UTP Cable will be delivered to GDC Kawi House store and not Nakuru, Polo Center.
7.	Indoor Access Points – Nakuru Office Quantity = 10. Is the cabling infrustructure already in place or should be charged for each site?	Cabling Infrastructure is availbale and should there be need for more GDC will avail.
8.	50 boxes (305Meters (1000feet) Reelex) Are the cable boxes just been delivered or will also be installed? If so, how many points are to be installed?	The Schedule is for Supply, there is no installation.
