ADDENDUM 1: CLARIFICATION/AMENDMENT

In response to the request for clarification, GDC wishes to respond as follows.

No.	Bidders Query	GDC Response
1.	Regarding Tender No. GDC/ICT/OT/037/2023-2024 for the provision of a service Level Agreement for Data Center Maintenance over a two-year period, we have observed a potential overlap in Mandatory requirements for NCA and EPRA; Requirements: 18 (Provide ERC Electrical Contractor Registration Certificate, 19 (Provide Valid NCA Accreditation – Electrical Engineering Services. This will be verified on the NCA Portal.), 20 (Bidders Must attach an NCA 1/2/3 Electrical certificate.) and 21 (Bidders Must attach EPRA A/B/C Electrical Construction License) under the Mandatory Requirement Section III.  We kindly request that these requirements be considered on an either/or basis instead of requiring both. Both certificates signify the electrical qualification of a firm to undertake any electrical related works.	

2.	Item no 17. Provide a valid Communications Authority (CA) license: SINCE THE WORK INVOLVES DATA CENTER, CAN EITHER A VALID ICT AUTHORITY (ICTA) -DATACENTER LICENSE OR CA	GDCs requirement remains as is. This is because the Data Centre houses critical communication infrastructure.

3.	Item no 21. Bidders must attach EPRA A/B/C Electrical Construction License: CAN ELECTRICAL LICENSE FOR COMPANY DIRECTOR BE USED ALSO TO REPRESENT THE COMPANY?	Provide either a Valid NCA or EPRA Accreditation for – Electrical Engineering Services or Construction. Bidders must attach an NCA 1/2/3 Electrical Certificate or an EPRA A/B/C Electrical Construction License for the bidding company.
4.	In line with section 10.1 of the tender document, GDC wishes to correct the tender description from Tender for Provision of Service <u>Legal</u> Agreement for Data Centre Maintenance for a Period of two (2) years to;  • New Description - Tender for Provision of Service <u>Level</u> Agreement for Data Centre Maintenance for a period of two (2) years.	

All other requirements/instructions remain unchanged.
