GDC falls under the Ministry of Energy & Petroleum (MoE&P). The Company has offices in Nairobi, Naivasha and Nakuru towns with most of its operations within the Menengai Caldera in Nakuru. Drilling operations are set to begin in the North-Rift areas of Baringo County.

SCOPE OF THE ASSIGNMENT
