3.	Kindly provide us with the required Genset plinth area structural drawings, or clarify if we should develop on our own?	Bidders to develop own plinth designs & drawings as per site conditions provided during site visit.
4.	Kindly clarify if the cables will be mobile or permanently terminated to the existing systems at both the three locations? which means we shall provide cabling for all the three locations.	Cables will be provided for all the three pumping stations/locations.
5,	In the tender document, the required sound level for the silencers is indicated as <=10dB.  Most gensets of this size have a 90 dBA at 1 meters, or 75dBA at 7 meters, we seek clarification for the required sound pressure levels.	The required sound level 60-80dBA at 7m
