According to the mandatory requirements, a written confirmation letter stating the prices quoted shall remain valid for a period of twelve (12) months (1 year) from the date contract should be provided. We kindly request that you reconsider this requirement due to price fluctuations in the Supply Chain.	The requirement remain as stated in the tender document.
2.	According to the invitation to tender, the closing date is due and would like to request for a one week extension	The tender closing date has been extended from 20 th September 2021 to 24th September 2021 at 2:00PM. This is meant to give interested tenderers adequate time to prepare and submit a responsive bid.
3.	According to the tender qualifications, a tenderer is required to have completed at least three (3) contracts of a similar nature either within Kenya, the East African Community or abroad. This being an AGPO tender, we kindly request that you reconsider this qualification.	and submit a responsive bid. Tenderers in the target group who may not have capacity as defined by this tender are allowed to form a joint venture with manufactures /dealers/ established entities to meet the Requirements as stated in Preliminary/Mandatory Evaluation Requirements/criteria, criteria number 20. Under this arrangement the following conditions must be met & provided. i) A formal partnership agreement /Joint venture Agreement signed by both parties must be submitted with the bid document. However, in the agreement, the lead party should be the entity owned by the Youth with a valid AGPO certificate. ii) The roles of each party must be defined in the arrangement. The lead however must be occupied by the entities from the Special group. iii) Attach power of attorney
